TO DECLARATION OF CONDOMINIUM AND LEASE
(CAR Version)

The undersigned Officers of CHATHAM I
Condominium Association, pursuant to the Declaration of
Condominium as recorded in Official Records Book 2191, Page
491, Public Records of Palm Beach County, and amendments
thereto do hereby certify that at a duly held meeting of the
members of the Association, on the 6 day of
April, 1986, at which a quorum was present, the
following Resolutions were duly adopted by the Association's
members casting the required votes of the membership and
which said Resolutions are still in force and effect, to-wit:

RESOLVED, that this Association adopt, approve and
join in an amendment of its Declaration and Long-Term Lease,
substantially in the form of AMENDMENT TO LONG TERM LEASE
which has been presented to, and discussed at, this meeting,
and which is set out as recorded in Official Record Book
5179, Page 1469, Public Records of Palm Beach County.

WE FURTHER CERTIFY that the meeting at which said
Resolutions were adopted was called and held pursuant to and
in accordance with the requirements of law, the Declaration
and the By-Laws of said Association and Section 718.110 Fla.
Stat.

drafting error in the said Amendment and wishes to correct
the scrivener's error. To correct this error the Parties
agree that the reference on Page 4, Paragraph 8 of the said
Amendment to "Article 4" of the Master Amendment" was a
clerical error and intended to mean Article 5 of the Master
Amendment. Furthermore, Article 2.2 of the 1980 CAR "Master
Amendment", relating to \$100,000 capital replacements, was
intended to be repealed and is in conflict with the
Amendments and therefore shall not be implemented.
