1999 UCO MODEL DOCUMENTS EXHIBIT TO AMENDMENTS TO THE DECLARATION OF CODOMINIUM AND BYLAWS OF NORTHAMPTON J CONDOMINIUM ASSOCIATION

1. Amendment to Article XI of the Declaration, "Provisions Relating to Sale or Rental or Other Alienation or Mortgaging of Condominium Units" is amended as follows:

No Lease of any unit shall be less than six (6) months and one day and no unit may be leased more than once in a twelve (12) month period. The provisions of this Amendment shall not apply to leases already reviewed and approved by the Association as of the effective date of this Amendment. However, this Amendment shall apply at the expiration of any such existing leases.

A unit may not be rented until the expiration of twenty four (24) months after purchase or acquisition of an ownership interest by an owner. The purchase of a unit is deemed to have occurred on the date the owner acquires an ownership interest in title. The restriction on renting a unit as provided above shall not apply to an Institutional First Mortgage holder, Northampton J Condominium Association, Inc., or the Lessor under the Long-Term Lease should they acquire title to a unit through foreclosure sale or by deed in lieu of foreclosure.

2. Amendment to Article IX. ACUISTION OF UNITS as follows:

Section 3. No owner may acquire and hold an ownership interest in more than two (2) units at any one time.
