As used herein (unless substantially reworded) the following shall apply:

A. Words in the text which are lined through with hyphens indicate deletions from the present text.

B. Words in the text which are underlined indicate additions to the present text.

C. Whenever an ellipsis (. . .) appears in the text this indicates that this portion of the present text remains intact to the point where the next typewritten material appears.

ARTICLE I, Section H of the Declarations of Condominium is amended as follows:

ARTICLE I

H. Common expenses mean the expenses for which the unit owner is liable and shall include, but not be limited to the expenses of the operation, maintenance, repair or replacement of the common elements, costs of carrying out the powers and duties of the Association, reasonable bus transportation services, security, and insurance for Directors and officers which are reasonably related to the general benefit of the unit owners, even if such expenses do not attach to the common elements or property of the condominium.

I HEREBY CERTIFY that the above amendment was approved by in excess of seventy-five percent (75%) vote of the total eligible vote of the Association at the membership meeting held on November 10, 1988.
