
As used herein (unless substantially reworded) the following shall apply:

Article XIII Use and Occupancy of the Declaration of Condominium is amended as follows:


The owner of a unit shall occupy and use his apartment unit as a single family private dwelling, for himself, the adult members of his family, and his social guests, while he is residing, ~~and for no other purpose. Only the owner's adult children may occupy the unit in the owner's absence~~ If the owner so desires the unit may be rented to an eligible person or persons approved by the Board of Directors but for a period no shorter than 6 months and only after the owner has held title to the property for a minimum of two years. The owner is solely responsible for any damages that may be attributed to said renter. Only the owner's immediate family, being limited to parents, brothers, sisters and adult children may occupy the unit in the owner's absence, for a period not to exceed two (2) weeks and with prior approval of the Board of Directors.
