As used herein (unless substantially reworded) the following shall apply:

Article \_\_\_\_ of the Declaration of Condominium is amended as follows:

SEE ATTACHED

WE HEREBY CERTIFY that the attached amendment to the Declaration was approved by in excess 75% vote of the membership or 51% of those present in person or represented by proxy (a quorum being present) at a duly called meeting on Dec/97, 1997 and does not affect the interests of the lessor of the long-term recreational lease.

SALISBURY "D" CONDOMINIUM ASSOCIATION  
BY-LAW AMENDMENT

Provided, however, each owner shall use such apartment as a private dwelling for himself or herself and his or her immediate family, and for no other purpose including business purposes. Therefore the leasing of apartments to others as a regular practice for business, speculative investment, or other similar purposes is not permitted. To meet special situations and to avoid undue hardship or practical difficulties the Board of Directors may grant permission to an owner to lease his or her apartment one time to a specified lessee for a period of not less than four consecutive months.

Salisbury "D" Condo association will allow the rental of apartment under the following circumstances:

- 1 - If an owner is confined to a nursing facility or extended care facility said apartment may be rented to help defray cost of same.
- 2 - If an heir is under the age of 55 years, said apartment may be rented until said heir reaches the age of 55 years.
