thereto do hereby certify that at a duly held meeting of the

members casting the required votes of the membership and
which said Resolutions are still in force and effect, to-wit:

RESOLVED, that this Association adopt, approve and
join in an amendment of its Declaration and Long-Term Lease,
substantially in the form of AMENDMENT TO LONG TERM LEASE
which has been presented to, and discussed at, this meeting,
and which is set out as recorded in Official Record Book
5173, Page 1469, Public Records of Palm Beach County.

WE FURTHER CERTIFY that the meeting at which said
Resolutions were adopted was called and held pursuant to and
in accordance with the requirements of law, the Declaration

the scrivener's error. To correct this error the Parties
agree that the reference on Page 4, Paragraph 8 of the said
Amendment to "Article IV of the Master Amendment" was a
clerical error and intended to mean Article V of the Master
Amendment. Furthermore, Article 2.2 of the 1980 CAR "Master
Amendment", relating to \$100,000 capital replacements, was
intended to be repealed and is in conflict with the
Amendments and therefore shall not be implemented.
