1. Article XI of the Declaration is amended as follows:

**PROVISIONS RELATING TO SALE OR RENTAL OR OTHER ALIENATION OR
MORTGAGING OF CONDOMINIUM UNITS**

A. SALE OR RENTAL OF UNITS –

(...) the Board of Directors may grant permission to an owner to lease his or her apartment one time during the ownership of the apartment, for not more than one year, to a specified lessee. Said lease shall be non-renewable.

The Board, upon application and review, may grant exceptions to occupancy and allow a limited number of persons ~~under~~ under the age of fifty-five (55) when the Board finds undue hardship to the applicant.
