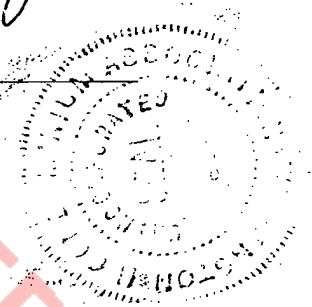

The original Declaration of Condominium of Wellington "H" Condominium is recorded in Official Records Book 2151 at Page 308 of the Public Records of Palm Beach County, Florida.

As used herein, words underlined are added and words ~~hyphenated~~ through are deleted.

Article XVII(3)(6) of the Association By-Laws shall be amended to read as follows:

No Unit Owner shall park or store ~~or leave~~ boats, trailers, trucks, commercial vehicles or ~~motorcycles~~ motor homes on the Condominium property. Motorcycles are permitted provided that they have mufflers.
