This month, however, our Clubhouse Library was closed on July 21. There were four of us who volunteered to clear out some items that had been there so long they were starting to smell. With the cooperation and encouragement of Anita Cruz, the entire maintenance crew came to help. I first want to thank the Transportation Committee for agreeing to return for a continuation meeting. We had much to do and they went home with homework. I also had been given homework from our Treasurer, Dorothy Tetro, who brought the recent gas bill to my attention. Unbelievable!  
**Gas** prices are our enemy and the committee has worked diligently trying to eliminate overlapping routes and what can be done to save money with minimal impact on service. They submitted their recommendations and the analysis of the information will begin. The results will be presented at the next Transportation Meeting on Monday, August 18, 1:30 p.m. at the Clubhouse (usually in Classroom B, but check with desk).  
On a positive note, it was voted to zig-zag through the streets of Camden and Windsor. We already have stops in the area but going this way makes it a continuous run. The start date will be published later as two benches must be moved and additional stop signs must be installed.  
We discussed with Anita Cruz of WPRF Inc. the possibility of overnight parking

near Duck Island. She will consult with her legal counsel and get back to us. For further information on this subject, please refer to her article.  
Now back to the subject of GAS. We have met with the owner of the Chevron gas station at the corner of Military and Community. They informed us that they have a generator which will be needed during hurricanes in order to refuel. They also will set up a special lane for our buses during and immediately after hurricanes so they do not have to wait in line with the cars for fuel. The best part is we will be paying pump price less five cents per gallon on our usage of approximately 3,000 to 3,500 gallons per month.  
You are probably receiving this publication after my return. However, I will be gone until August 17, so if you have left any messages and have not received a call back, please be patient and I will make every effort to call upon my return.

We have moved the Biography (green dots) section to the back right, next to the plastic magazine rack. Green labels are being identified with the first letter of the name of the person written about, such as “R” for Roosevelt, regardless of the author’s name.

The History (blue dots) section has also been moved to the back left. We’ve moved the remaining jigsaw puzzles to the bottom shelves in various bookcases, because many people were unable to reach them at the tops of the bookcases. In fact, we have cleaned all the tops of all the bookcases, so the only things remaining are various items of art.

Untouched were the Foreign Languages, which are being maintained by other volunteers. New signs are posted, and a section has been identified as Trade Novels. These appear to resemble paperbacks, but are taller, and in a different category, called Trade by librarians. □

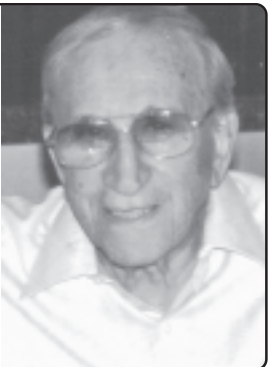



**Next Year Looks Even Wor\$e**

A couple of months ago, I explained how the housing slump, state-mandated revenue cuts and voters’ adoption of an additional homestead exemption (Amendment 1) would make this an especially difficult budget process. Well, things are worse than we thought. And I’m sorry to say next year looks even bleaker.

Unlike several cities facing similar revenue shortfalls, the BCC (Board of County Commissioners) is *not* raising the millage rate this year to make up the difference. We have decided to get by with whatever revenue has already been collected. Each week it seems there is a new list of county jobs, programs and services on the chopping block. Making these cuts is painful, but it’s what the voters said they wanted.

We’ve cut funding for road construction, median landscaping and beautification, building permit processors, vegetation inspectors, sheriff’s vehicles, business incubators, and teen residency shelter beds, and we’re not done. Some of these cuts have been initiated now to reduce the hit on reserve funds. We can’t afford to deplete our reserves in case we have a major storm or some other catastrophic emergency.

Next year (FY-2010), Palm Beach County is anticipating at least a five percent loss in property valuation, and our administrator says to expect a \$110 million budget shortfall if the millage rate remains at 3.78 mills. Even if we decide to raise the millage rate — something the BCC hasn’t done since 1998 — to the state-allowed rollback rate of 4.07 mills, we

will still be looking at a deficit of \$60 million.

So, how do we close this shortfall? Tapping reserves again is out of the question, and there’s nothing left in the capital budget because we killed just about every project this year. That leaves a huge hit to the operations budget; major layoffs and deeper service reductions are inevitable.

Besides trimming everywhere we possibly can, I think we need to look at some new revenue sources, such as user fees. For example, boaters may have to pay \$10 a year for a permit to use our county boat ramps.

Parking is currently free at county-owned beach parks, while most municipal beaches have meters. Maybe the county should start charging for beach parking, too.

The Juno Pier charges a nominal admission. Why not ask a dollar or two to stroll out on the boardwalks at the Wakodahatchee and Green Cay Wetlands facilities?

Golfers pay greens fees. Wouldn’t tennis players kick in a few dollars to play on our county-owned tennis courts?

How about \$1 to borrow a book or a DVD from the library? It’s still a lot cheaper than buying them.


Palm Tran and Tri-Rail are experiencing record ridership. Maybe their fares should be increased to cover more of their operating costs.

I realize that none of these options will be very popular, but lawmakers and citizens who demanded property tax relief had to know there would be a trade off in public services. That’s just basic economics.

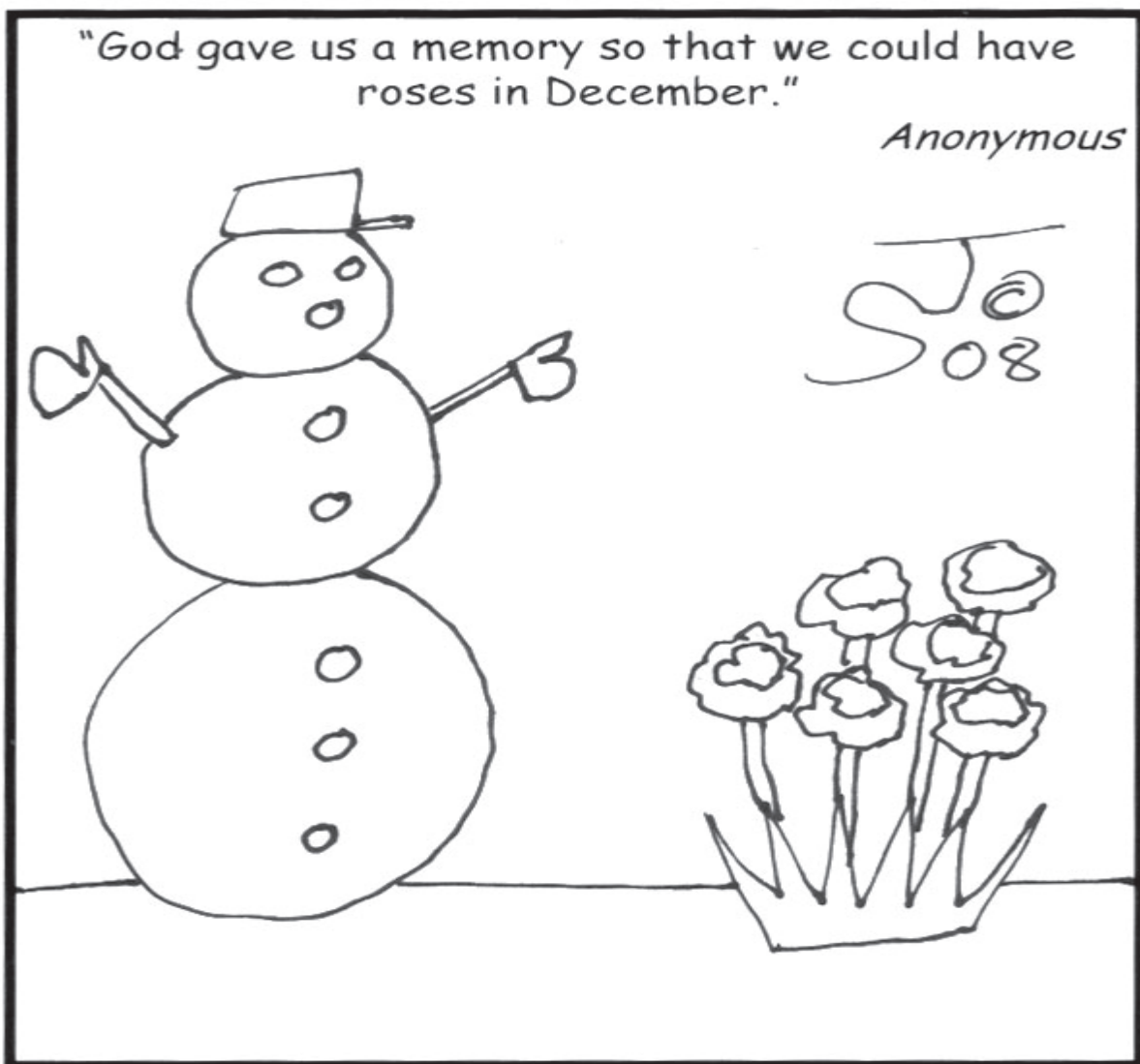

(Community Emergency Response Team)

I hope we have not become complacent again, Hurricane season is still upon us. It is still important for us to make all provisions in case of a storm. This means medical supplies, food stuffs, water, lanterns or glass enclosed candles and flashlights.

On August 4, 2008, CERT conducted its first emergency drill. The phone team did a great job in contacting all members. There were 15 people and three HAM operators that were present. We still have a good deal of work to do, but we will be ready in case we are needed in the Village.

## Hurricane Check List

Below is a list of things you should do before, during and after a hurricane. This short list was put together from all the information the Emergency Committee could find.

### Things to Do Now

- Review your insurance policy.
- Register with the Emergency Management program if you must depend on electricity for your life support in any manner. Example: oxygen, refrigeration for insulin, etc.
- If you want to install shutters, speak with your Association President. Storm panels are recommended. (Note: Century Village is not an evacuation area. Our buildings and our area are considered very safe in a hurricane.)
- If you are leaving for the hurricane season, remove or secure all items on your patio. Take them inside. Remember, it is not the wind that destroys, but the objects the wind throws around that causes destruction.
- Select a safe room in your apartment, away from windows and doors and all flying debris. Example: Use your bathroom if it has no windows, or a hallway.
- Check stair lights and emergency lights on building.

### Things to Do One or Two Days Before the Storm

- Remove all patio furniture. Install your shutters.
- Remove recyclable containers to your laundry room and secure your Dumpsters. Tie down lids.
- Fill your car's gasoline tank.
- Turn your refrigerator and freezer to its coldest settings and freeze water in plastic jugs. They will keep food colder longer, if electricity goes off, and when thawed out, can be used for drinking.
- Wear your Medic Alert tag.
- Clean your bathtub and then fill with water for sanitary purposes. This is not for drinking.
- Place all your valuables, such as treasured pictures, personal papers, insurance papers, etc., in waterproof containers or plastic garbage bags. Store them on the top shelf of the closet. Also wills, contracts, deeds and bonds, passports, Social Security cards, bank accounts, immunization cards, birth certificates, etc.
- Secure checkbook, cash, ATM card. Do not leave valuables in a home safe during the hurricane.

Good news again: There have not been any major crimes in the Village again. Palm Beach Sheriff's Office again reported a few "Fender Benders" and tickets for speeding or failing to stop. There have been some problems outside three units facing the golf course. The golf course's fence along Haverhill Road is broken and they are not interested in repairing the damage to the fences, so we must protect our own property by locking our property and having enough light on to keep people away from our buildings. Also, always lock your car.

We request that you make sure that a key to each door is available to the President of your building to assist the 911 response person. On a recent day, four phone numbers were

called to get the building keys and no one had the keys. It was necessary to break the front window to gain entry to this unit when the owner needed help. It is also necessary to have a valid contact person listed so that we can call to help make plans when an emergency happens. The Building President should have this information.

Finally, thank you for showing your IDs to the guard at the gate after your fellow residents break the gate arm. The only gate that has been broken in the past few months is a **resident** transponder gate. Please ask your driving friends to slow down when entering the automatic gate. The gate is not controlled by the guard it is

### Kit Check List

- Water — the most important! One gallon per person, per day. Portable cooler.
- Packaged foods — canned meats, fruits, vegetables, juices, milk, soup, sugar, salt, pepper, peanut butter, jelly, crackers, granola bars, cookies, hard candy, sweetened cereals, instant coffee, tea bags.
- Manual can opener (not one operated by electricity).
- Toiletries — toilet paper, soap, feminine supplies, denture needs, extra eyeglasses.
- First aid kit — bandages, gauze pads, tape, scissors, tweezers, needles, antiseptic, safety pins, sunscreen, aspirin.
- Battery operated radio and extra batteries, for flashlights, etc. and charge rechargeable batteries.
- Eating utensils — paper cups, plates, plastic knives and forks.
- Extra medicine — prescriptions.
- Flashlights. Matches. Candles.
- Plastic trash bags — to store many of the items in this section.
- Change of clothing. Gloves. Mosquito repellant.

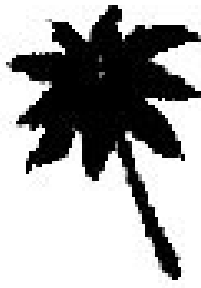
### During the Hurricane

- Stay in your safe room or hallway.
- Close and stay away from all windows.
- If electricity goes off, use only flashlights during the storm.
- Keep on your person at all times keys to home and car, driver's license, cash.
- Bring into the safe room a pillow or mattress in case you need to cover yourself from flying debris. Also, bring in as many items from the hurricane list as you can — especially drinking water.
- If no electricity, use your battery-operated radio and tune in to FM 100.7 Y-100; 107.9 WIRK; 102.3 WHLG; AM 1290 WBZT; 1450 WSTV. Don't listen to rumors. Get the truth from the radio.

### After the Hurricane

- Stay tuned to the radio for instructions.
- Don't use the telephone, unless you have a life-threatening emergency.
- Don't drink tap water unless you are told it is OK. Boil the water for five minutes before using.
- Do not refreeze thawed out food. If electricity is out, try store foods in freezer compartment.
- Your Security and C.O.P. rover cars will be around to make sure all buildings are secure. □

This month, we and WPRF finally have reached the final step of rearranging and putting together the package deal of the insurance policies of WPRF.

Our deductibles have changed from \$3 million flat deductible on every occurrence to \$600,000 deductible on the Main Clubhouse, \$100,000 on the gym, \$37,000 on the contents, and so on.

And above all, the renewal premiums are cheaper than the previous year.

Last month, the Governor signed into law the new HB601 that rewrites the insurance part of 718.111(11). Here are some highlights that we chose to give you some idea on the changes. The quotes from the new law speak for itself and it put much more responsibility on the unit owners and removes a lot of the burden from the Associations.

Partial Highlights of HB 601

The bold type is UCO’s; see disclosure at the bottom. HB 601 is a complete rewrite of 718.111(11) — (the insurance section).

After a casualty, if the Association insures it, the Association repairs it and if there is not enough money from insurance proceeds (because of a deductible or otherwise), the Association will assess.

If an owner makes **an improvement** (for example, a balcony enclosure), the unit owner will be **required to insure it and repair it** in a casualty, even if the improvement is **outside** of the unit boundaries. The bill also revises the Association’s insurance responsibility.

It must have adequate insurance and have it appraised every three years for the replacement value.

*HB 601 changes.* The Association will be required to insure A/C + compressors.

After January 1, 2009 **home-owners insurance** of individual owner **must** contain a provision to include special assessment coverage of no less than \$2,000.00 per occurrence.

All improvements or additions to the condominium property **that benefit fewer than all unit owners shall be insured** by the unit owner or owners having the use thereof, **or may be insured by the Association at the cost and expense of the unit owners having the use thereof.**

The Association shall require each owner to provide evidence of the currently effective policy of hazard and liability insurance... Upon the failure of an owner to provide a certificate within 30 days, **the Association may purchase a policy of insurance on behalf of an owner.** The cost may be collected in the manner of collection of assessments.

All reconstruction work after a casualty shall be undertaken by the Association. A unit owner may repair only with **written consent of the Board and after** the method, qualifications, etc., was approved by the Board. The **owner** shall get the permits.

Unit owners are responsible for the cost of reconstruction of the condominium property for which the unit owner is required to carry casualty insurance and any such reconstruction work **undertaken by the Association** shall be chargeable to the unit owner and enforceable as an Assessment. **The Association must be an additional named insured and loss payee on all casualty insurance policies issued to unit owners.**

Any portion of the condominium property insured by the Association in casualty shall be, repaired, as necessary by the Association as a **common expense**. All insurance **deductibles, uninsured losses,** and other damages in excess of hazard insurance coverage maintained by the Association **are a common expense except that:**

A unit owner is responsible for any portion of the condominium property not paid by such insurance proceeds, if such damage is caused by **intentional conduct, negligence, or failure to comply** with the rules of the Association by a unit owner.

The Association is not obligated to pay for repair of casualty as a common expense if the casualty losses were **known or should have been known** to a unit owner and were not reported to the Association **until after the insurance claim of the Association was settled or resolved.**

An Association is not obligated to pay for any repair due to casualty loss to any improvements installed by anyone if it **benefits only the unit** for and is **not part of the standard improvements installed by the developer on all units** as part of original construction, whether or not such improvement is located within the unit.

The effective date of HB 601 is July 1, 2008. As of 6/7/08, the Governor has not signed it into law.

Before starting my article, I'd like to sincerely thank everyone who elected me a Vice President of UCO. I'll try to improve conditions in Century Village and try to help bring peace to the Village. I'll also continue to chair the Maintenance Committee.

Attendance at the maintenance meetings keeps getting larger and larger. At the past meeting we had over 120 Association Presidents and Board members present. Before the meeting started, there were a few announcements:

- All Delegates should try to attend the monthly Delegate Meetings, otherwise, they are missing out on a lot of information that is made available to them. This information is not in the UCO Reporter because it is impossible to print everything said at our monthly meetings.
- Our disclaimer precedes every meeting: UCO and

the Maintenance Committee do not approve or endorse any product, manufacturer, or contractor, and furthermore, this article cannot be used in any legal matter.

- Another water drip alarm is sold in Lowe's for about \$13 plus tax. You will find it in the section with hot water tanks. Thank you to the person who attends our meetings for the information that led me to find this less expensive water drip alarm. A word to the wise: Don't get caught in the middle of the night if the water heater goes — it is not the type of problem you want to have. This device could give you some warning when your water heater starts to leak.

I asked if everyone had received a handout that was prepared, dealing with a new amendment to their documents, concerning the new regulations that went into ef-

fect the first of this year regarding the new hurricane codes. We then explained that this handout was prepared so that an Association could determine what they could put into their documents regarding the upgrading or replacement of hurricane shutters, windows, doors and/or patios. Most important is that the Board of Directors must give written permission before anyone can install hurricane proof shut-

ters, windows, doors, or rebuild patios on their unit. This handout could be used as a guide for the wording to be used in writing these amendments, and it was stressed that this example is only a suggestion. The wording and content is up to the Board to write.

After the new amendment is prepared, the Board of Directors must vote to approve the new bylaw. If the vote is affirmative, all unit owners must

then vote to approve the same amendment, and record it with the county clerk for it to become legal. Every Board of Directors must realize that if they don't take any action on placing the amendments into their documents, any unit owner can put up whatever kind or color of hurricane protection they want. That is why the Boards of all Associations

This month's Safety article is written by retired New York City Police Department Captain Ralph Wugman, a Safety Committee member. It will focus on pedestrian safety.

Since a number of Century Village residents have been cited with moving violations, the question comes to mind. "How safe are we as pedestrians?" Are we placing ourselves in harms way by our failing to exercise safe practices in our use of the roadways and streets inside our village or on the streets of our city? Let me point out from my own recent experiences of unsafe pedestrian actions in Century Village:

- A female crossing a roadway using a cell phone not paying attention to traffic around her.
- A male walking and reading a book at the same time not watching where he is walking.
- A male walking in the roadway again not paying any attention to the oncoming traffic.
- I still see residents walking at night and not wearing light colored clothing or carrying a flashlight.

For safe walking habits outside of our Village, cross the street at **marked** crosswalks and intersections when possible.

- Make eye contact with drivers so that they see you.
- Buses and trucks take longer to stop; are you watching out for them?
- Pay attention to turning vehicles, especially trucks and buses making "Right turns on Red."
- Watch out for vehicles backing out of parking spaces.

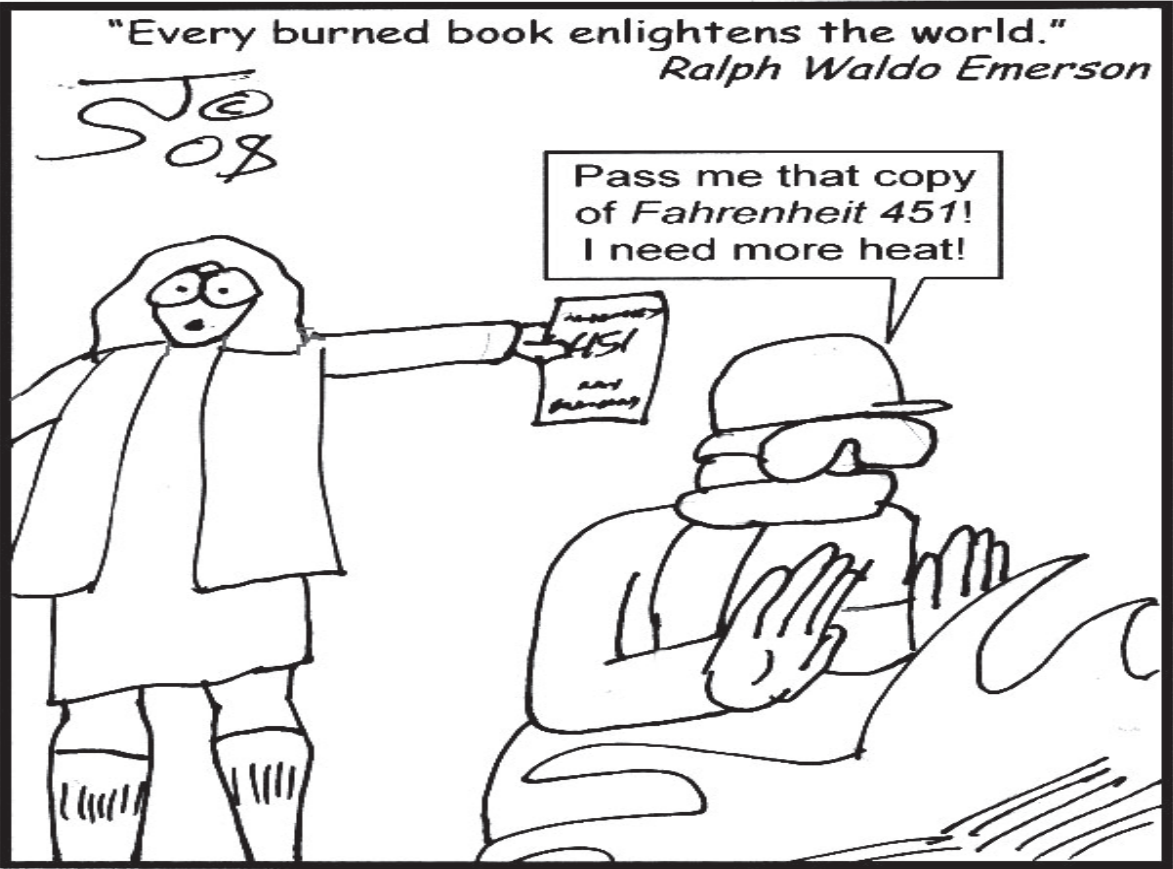

*Lone Survivor* by Marcus Luttrell, written with Patrick Robinson, is a true story of Navy SEALs, their training and missions.

In the first half of the book, Luttrell describes the physical and mental hardships he and the other frogmen (another name for SEALs) suffer during training. Once you read the day by day detailed account, you will never look at a SEAL the same way again. Their training is so intense and grueling that you can't help but be in awe of them. More than three-quarters of the men who start the program drop out.

The mission into the mountains of Afghanistan to kill a Taliban leader and what happens there constitutes the second half of the book. It deals with Operation Redwing. This raid leads to the death of three members of Luttrell's four man team as well as a rescue team aboard a helicopter. It

was the largest loss of life in SEAL history and the largest loss of Special Operations Forces since D-Day. How he survives, what help he receives along the way and the meaning of "lokhay warkawal" makes for fascinating reading.

Luttrell also tells the parallel story of what is happening back home in Texas, as told to him by his parents and his twin brother, who is also a SEAL.

While it breaks your heart to read of the deaths of these brave young men, it is also disheartening to read of their fear of "political correctness" and the outcome of this fear. "Was I afraid of the Taliban? No. Was I afraid of the liberal media back in the U.S.A.? Yes."

Though I do not agree with Marcus Luttrell's politics and the war in Iraq, I am extremely proud of this young man, and I know you will be, too, after reading his story.

*Where Are You Now?* by Mary Higgins Clark, number one on the *New York Times'* bestseller list. "Oh what a tangled web we weave, when first we practice to deceive!" If you want a suspense thriller and a fast read, try this one.

Mack Mackenzie disappears from his New York City apartment. Neither the police nor a private investigator finds any trace of him. Ten years later, his younger sister, now an attorney, decides to put her life on hold to try and locate him.

Once a year, on Mother's Day, Mack calls his mother to let her know that he is all right. This call and a note from him send his sister down a path loaded with twists and turns as she tries to solve the mystery of what happened to her brother. Along the way, she puts her own life in danger as she finds that her brother's disappearance is linked to four missing and presumed dead women. Clark makes many of the characters that Carolyn Mackenzie encounters appear to be involved in these disappearances as she helps us unravel the clues and brings us to a fascinating, not frustrating, conclusion.

Mary Higgins Clark is known as "the Queen of Sus-

pense" and she does not disappoint her readers with this latest novel, which she notes, is based on a true story. In this book there are no four-letter words, the heroine is smart and the characters are well developed (albeit, too many). Once again, this veteran writer has a hit. Read it if you are a fan of hers. If not, *c'est la vie*. □





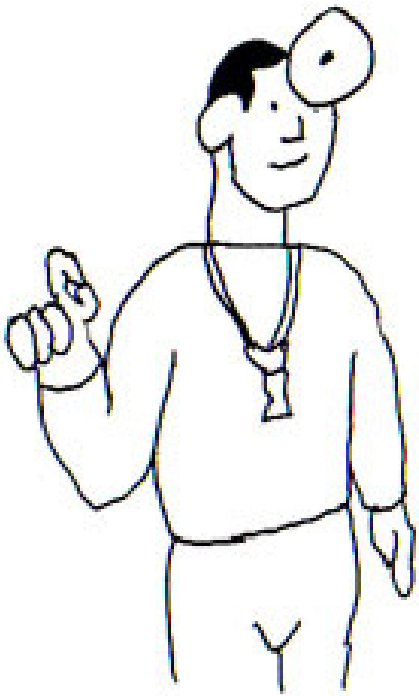

# Tales from the Cold War

**Researched by Dave Israel**  
**Project Venona**  
*"The real secrets are beyond  
 Top Secret and are known by  
 other names"*

VENONA is a Signals Intelligence (SIGINT) cover name for the Cryptanalytic exploitation of a specific High Grade Soviet cipher system. Such successes are among the most highly classified secrets of State and are normally never revealed publicly. In this case, some 50 years after the events in question, it was deemed “Critical” to a correct understanding of key historical events that this story be told.

Revelations from VENONA decrypts shed light on such sensitive matters as; the existence of Soviet espionage at Los Alamos National Laboratories. Identities soon emerged of American, Canadian, Australian, and British spies in service of the Soviet government, including Klaus Fuchs, Alan Nunn May and Donald Maclean, a member of the Cambridge Five spy ring. Others worked in Washington in the State Department, Treasury, Office of Strategic Services, and even the White House. The decrypts show that the U.S. and other nations were targeted in major espionage campaigns by the Soviet Union as early as 1942. Among those identified are: Alger Hiss; Harry Dexter White, the second-highest official in the Treasury Department; Lauchlin Currie, a personal aide to Franklin Roosevelt; and Maurice Halperin, a section head in the Office of Strategic Services. Perhaps the greatest point of controversy regards, in the opinion of this analyst, dispositive evidence of the guilt of Julius and Ethel Rosenberg.

According to his former KGB handler, Alexandre Feklisov, Julius Rosenberg was originally recruited by the KGB on Labor Day 1942, by former KGB spymaster Semyon Semenov. Julius had been introduced to Semenov by Bernard Schuster, a high-ranking member of the Communist Party USA as well as Earl Browder's personal KGB liaison. After Semenov was recalled to Moscow in 1944, his duties were taken over by his apprentice, Feklisov.

According to Feklisov, Julius was his most dedicated and valuable asset, providing thousands of classified reports from Emerson Radio, including a

complete proximity fuse, the same design that was used to shoot down Francis Gary Powers' U-2 in 1960. Under Feklisov administration, Julius Rosenberg is said to have recruited sympathetic individuals to the KGB's service, including Joel Barr, Alfred Sarant, William Perl and Morton Sobell. According to Feklisov's account, he was supplied by Perl, under Julius Rosenberg's direction, with thousands of documents from the National Advisory Committee for Aeronautics including a complete set of design and production drawings for the Lockheed P-80 Shooting Star. Feklisov says he learned through Julius that his brother-in-law David Greenglass was working on the top-secret Manhattan Project at the Los Alamos National Laboratory and used Julius to recruit him. Through this connection, key data on the Nuclear Bomb was given to the Soviets.

The exploited Soviet Crypto-system used a code to convert words and letters into numbers, to which additive keys from one-time pads were added, encrypting the content. When used correctly, one-time pad encryption is theoretically unbreakable. Cryptanalysis by American and British code-breakers revealed that some of the one-time pad material had incorrectly been reused (reuse of key is a violation of the principle rule of Cryptography) by the Soviets (specifically, entire pages, although not complete books), which allowed decryption (sometimes only partial) of a small part of the traffic.

Generating the one-time pads was a slow and labor-intensive process, and the outbreak of war with Germany in June 1941 caused a sudden increase in the need for coded messages. It is probable that the Soviet code generators started

duplicating cipher pages in order to keep up with demand.

It was Arlington Hall's Lt. Richard Hallock, working on Soviet "Trade" traffic (so called because these messages dealt with Soviet trade issues),

must make it very clear that unit owners must get their written permission before they purchase any hurricane shutters, windows, doors, or rebuild their patios. The Board of Directors will also have to make sure that unit owners use only contractors who are licensed and insured. Permits must be obtained before any installation work starts.

We then went into a discussion about House Bill 995, which concerns the major changes and additions to Florida Law Chapter 718. This bill is the largest rewrite of

Chapter 718 since 1978, and it contains many new laws and some changes to existing laws, so it is important that all boards in Century Village read them. Remember, H.B. 995 becomes effective on October 1, 2008, so do this as soon as possible. Because of all the detailed information that was discussed at this maintenance meeting about H.B. 995, it would be impossible to write it in this article, so it is recommended that you get your copy of this bill which is available at the UCO office.

The next meeting of the Maintenance Committee will be on Tuesday, September 9, 2008, in the Clubhouse Room C at 10 a.m. Dan Gladstone will be our guest speaker on the new House Bill 601, which deals with some changes to the Insurance Laws in the state of Florida. We will also discuss more of the ramifications of H.B. 995. □

How Old Is Old?

Living in a community like “Century Village” makes you acutely aware that you reside in a place where everyone is a senior citizen. Wherever you go, you are surrounded by residents with the badge of aging, “white hair.” When I leave for work every morning at 6:00 a.m., I don’t see the sun come up, but I do see dozens of our seniors walking singly or in groups taking an early constitutional before they begin their daily activities.

Wherever you go, the pools, the Clubhouse, the gym, you see our community in action. Norman Vincent Peale, the famous television evangelist, constantly reminded his flock, “Live your life and forget your age.” Century Village is a living example of this principle.

So where am I going with this theme? The other evening on the David Letterman show, he made a rude and insensitive remark about John McCain’s age. Before I continue with this tome, I want to be very clear to all my readers that this article is definitely not political. One of the continuing and persistent themes of the “talking heads,” and I am referring to radio, television and newsprint, is that McCain is too old to be a viable candidate for the Presidency.

I am, as I have already stated, not making a case for or against any candidate. What I am angry about is that so many people in the news media are taking a position that dismisses the older generation as mentally failing, lacking stamina, and mentally incompetent to make important decisions.

Someone once commented that “old age comes at a bad time.” However, what is the alternative? Have you ever thought about the good stuff that comes with old age? I did some research on the subjects and here are some very special insights. “Your investment in health insurance is finally beginning to pay off.” “Kidnappers are not very interested in you.” “Your eyes won’t get much worse.” “There’s nothing left to learn the hard way.”

The riddle was “What walks on four feet in the morning, two in the afternoon and three at night?” The answer was “Man.” This summarizes our journey from birth to death.

The boundary between middle-age and old-age really cannot be defined. It really does not have the same mean-

ing for all societies. In some societies, people are considered old when they become “Grandparents,” or when they retire. In America and in some European nations, you are considered “old” when you have lived a certain number of years or reach the age to become eligible to receive Social Security payments. In America, the politicians and social scientists refer to those citizens that have reached the age of 65 as senior citizens. Century Village, your place to retire and spend the rest of your days in sunny Florida, enjoying your Clubhouse and all the other amenities (as touted by Red Buttons) is a product of this thinking.

Senior citizens are fascinating people. They have lived a long time and they have seen so much. They tell such great stories about the world and how things used to be. It’s a wonder that young people to-

day have little interest in or even seem to care about the thinking of the elderly. How could anyone who survived the turmoil of the 20<sup>th</sup> century not have some real gems of wisdom to tell. I have always envied those who had grandparents because mine died when I was quite young.

My wife Phyllis is a prime example of a person who had her feet in three generations. Growing up in the Bronx, she had the great fortune to live in the same building as her “Bubbie.” She never hesitates to tell everyone about the role her “Bubbie” played in her life. Teaching her how to cook, to speak Yiddish, and the wonderful quotations that help explain the human condition. These were important. But on the top of the list was the deep intellectual insights to the human condition that she imparted to her and has made her

the woman she is today. My grandchildren call us all the time. They have questions to be answered. They want advice. They get it tempered with the wisdom of the elderly. The elderly have so much to share with each and every one of us that it’s a shame and a waste for younger people not to take advantage of the knowledge and wisdom that the older citizens can share.

I ask the younger generation to reflect on this. Have you ever gone to your grandma’s house and asked for a cookie, then take a huge bite and then scream that, “**this cookie tastes horrible.**” No. Because Grandma makes the best cookies, and she is old.

It’s unfortunate when the media deign to portray older folks at all, but when they do, it is almost always shown in

While many of our residents are away for the summer, our WPRF staff is working hard. It has been, and continues to be, my goal to improve the appearance, comfort and convenience of the recreational facilities here in Century Village, and your comments and suggestions have helped me gain insight into areas for improvement.

**Summer Work:** We have been working on several projects this summer, including:

- Improvement of the HVAC system, which is nearing completion with only a couple of trouble spots left (we have also changed AC companies once again for better service).
- Painting of interior hallways and rooms (a year-round on-going project).
- Complete remodeling of the Hastings fitness Center swimming pool.
- Landscaping improvements to the Clubhouse front island and walkways.
- Redesign of the Theater seating to better accommodate wheelchair seating and increase the number of overall seats.
- Installation of new metal exterior doors at various locations around the Clubhouse.
- Revitalization of the Art Committee, which is now actively accepting residents' art work for a rotating display throughout the Clubhouse, and planning for an Art Show this coming February (more details about the Art Show will be made available to you in the coming months).
- Our residents now have access to a computer, located in the Staff Office, available for use throughout the day, including WIFI capabilities for Internet access.
- General maintenance throughout the facilities, including installation of new gutters on the North side of the building.
- Installation of new Pool Rules and Regulations signs at each pool.

And speaking of rules and regulations, such as those currently in effect at our pools, you may be interested in how such rules are implemented. While the UCO Operations Committee has the right to set

all policies under the Millennium Agreement, WPRF and the UCO Operations Committee have worked together to find the best method available to ensure that new or changed policies are fair and are properly enforced. This applies to the pool rules as well as the general rules and regulations for all WPRF facilities with respect to resident and guest passes and dress codes.

Unfortunately, many of the rules and regulations are necessary to keep in place, and doing so does not please all of our residents. A good example

of this is the recent changes in the dress code for swimming in the pools. In prior years, residents were allowed to swim with t-shirts over their bathing suits while in the pool; however, our security guards are enforcing the posted rules which prohibit the wearing of "street clothes" in the pools, which includes cotton t-shirts. Those residents who are looking for an approved "top" to wear in the pool for protection from the sun are urged to wear tops made of swimwear-like material (Lycra, spandex or polyester), now available in most retail stores. In addition, the rules prohibiting food at the pools are now being enforced unless the food is brought to a WPRF-approved function.

Another summer task keeping me busy is the preparation of the annual budget for presentation to the UCO Operations Committee. Each year, I present my plans for the coming year's operations, including additional projects I would like to implement, and I will be making my initial budget presentation at the end of August. Some changes, deletions and/or additions are always made to the first draft of the budget, after which the UCO Operations Committee and I agree upon and finalize the coming year's budget for presentation to the delegates no later than October of each year.

One last item of interest to many of our residents — Karaoke has **not** been cancelled. Many logistic and operational changes have been necessary, but we still offer Karaoke to our residents in the Party Room on Tuesdays and Fridays.

Thank you all for your phone calls, suggestions and letters about those items of interest to you. It is your valued input that assists me and the UCO Operations Committee in making wise decisions. □

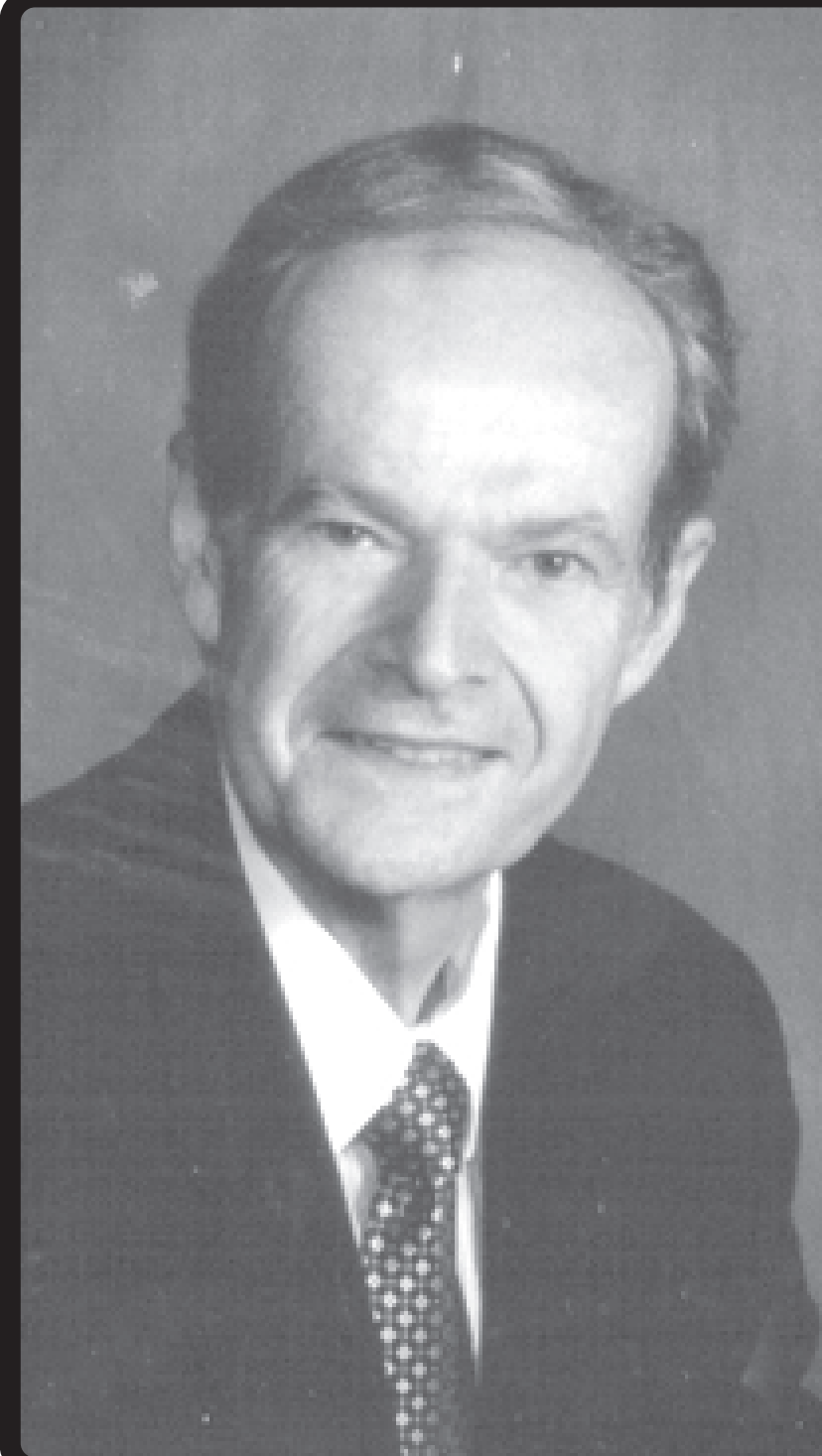

would lace up in the front. A tightly tied lace was worn by a proper and dignified lady as in "straight laced."

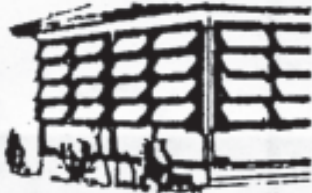

In these times of stress facing Americans — wars, high gas prices, foreclosures, bankruptcies, job losses, soaring food prices, to mention a few — we all could use a little “cheering up.” Right ?!?

That is why the U.S. Postal Service tells us, in stamp form, to get happy, and forget your troubles. There are so many occasions in life to celebrate. Thus, the recently issued “Celebrate” stamp has been reissued to acknowledge a host of happy occasions, from birthdays to engagements, to anniversaries and more. When good times call for good wishes, this stamp design will add a touch of cheer to special greeting cards and gift-bearing packages.

The stamp design consists of 12 colorful blocks arranged in four horizontal rows, with three blocks in each row. Each block in the top three horizontal rows contains a single letter of the alphabet, and together, the blocks spell out the word “Celebrate.” The three blocks in the bottom row contain an exclamation point, a star, and the denomination, 42 cents.

Seventy-five million stamps were printed. First day of issue postmarks can be obtained by mail. You may purchase the new stamps at your local post office or call 1-800-STAMP-24. You can affix the stamps to your envelopes, address them and place in a larger envelope and send to: Celebrate Stamp, Postmaster, Special Cancellations, P.O. Box 92282, Washington, D.C., 20090-2282.

Would you prefer a single, colorful “Happy Birthday” stamp ?!?

The Postal Service has those in stock too. Three Happy Birthday stamps have been released — in 1987, 1988, and one in 2002 fulfilling the mailing needs of the public. The design shows the word “Happy Birthday” in multicolor.

“We continually receive requests for this stamp,” says Manager of Stamp Development Terrence W. McCaffrey.

The master of fun and celebration, of course, is Walt Disney.

Disney fans have long hoped to see U.S. commemorative stamps featuring some of their favorite characters. In 2005, the USPS issued four stamps showing Disney famous characters. McCaffrey, who also designed this set of stamps, commented, “Disney characters have such wide appeal not only in the U.S., but also worldwide. A collaboration between the USPS and Disney was a natural pairing.”

The four stamps in the set show Mickey and Minnie, Alice in Wonderland and the Mad Hatter, Snow White, Happy and The Little Mermaid.
