From the Desk of President George Loewenstein



It is so sad that there are unit owners in this village who write letters smearing the names and reputations of candidates who are willing to donate their time and energy on behalf of our residents. We should be grateful that we have folks that are willing to assume the mantle of leadership rather than discouraging them by subjecting them to this kind of negativism. Although our administration has repeated again and again "we will not bash anyone in our newspaper" some have learned that the Blog can be used for any purpose, bashing or not. However, I must say that those who monitor the Blog immediately removed one item recently. Therefore, it is a mystery as to how this item managed to become anonymous, copied and distributed to the entire village. It is so sad.

Since this will be my last column as president, I would like to first of all thank the residents for having given me the opportunity to serve in this capacity over the last four years. It has been a very rewarding and satisfying experience for me. Much has happened over these past four years, and I would like to share some of the highlights with you.

I took office as president in March of 2006 after having been the treasurer for the prior two years. Within two months after being installed, we were able to reopen the clubhouse. We instituted a weekly Cabaret Night in the Party Room where I often acted as Emcee. We also enlisted the help and support of Mark Levy and his staff to work on the theater. In May of 2007 we cut the ribbon and celebrated with a wonderful free performance of several acts, thanks to Abby Koffler.

At that time we also instituted our Usher Corps under the guidance of Claudette LaBonte, replacing a paid staff, and saving the residents over \$60,000 a year. We convinced WPRF to issue passes to non-resident unit owners whose apartments were vacant, so that they could enjoy the facilities.

The Maintenance Committee was re-activated under V.P. Jerry Karpf. It has proven to be one of the most popular committees. We also have periodic meetings of condo presidents, chaired by Gerry Sutofsky. We broke up the Security committee and formed a separate Safety committee co-chaired by George Franklin and Michael Rayber.

Under the chairmanship of Ken Davis with the able assistance of Ed Black, we began taping the delegate meetings for later broadcast on Channel 63. We initiated many town meetings to disseminate important information. Lately we have broadcast interviews with various committee chairs.

#### **Proposed UCO Bylaw Amendments**

(Additions shown by "underlining", deletions shown by "strikeout", unaffected text indicated by "... ")

Section A, Paragraph 1 (unnumbered), lists the officers of UCO and proposes to include the President Emeritus as an officer of UCO. The term "officer" and "office" have long been used synonymously in the UCO Bylaws, and incorrectly so, according Florida Statutory Corporation Law and our attorney. It has always been assumed that the 'office of the President Emeritus' was indeed an officer's position, though this section failed to perfect this intent by not specifically listing it as an officer's position. The President Emeritus has, as a matter of practice, always been included as a member of the Officers' Committee, though the Bylaws restrict full membership in this committee exclusively to officers. The President Emeritus has also always been considered a member of the Executive Board by virtue of his presumed position as an officer. To quote from a recent correspondence from UCO's attorney "Remember that the term "office" is broad enough to include a Delegate, whereas the term "officer" is the President, VP, etc." The President Emeritus (or any other officer of UCO) will no longer be referred to as "holding an office", but more precisely, occupying the position of an officer. As such, the duties and responsibilities of the President Emeritus shall be stricken from this section and properly placed in AR-TICLE VII, "DUTIES AND RESPONSIBILITIES OF OFFICERS", newly added section <u>F. PRESIDENT</u> EMERITUS".

Due to the recent changes in Chapter 617, Florida Statute, UCO has been reclassified as a "Mutual Benefit Corporation". As per the direction

Sorry, we are not realtors, lawyers or a title company. Any questions or advice should only come from them.


We do not have blank leases or contracts for sale here.

## Taking on the Giant Where we were

A few years ago, our cable-TV company, Adelphia, got taken over by Comcast, the giant in the cable-TV industry. Comcast violated our old Adelphia contract by doing away with seven of our channels, one being our third HBO channel. At the same time, our contract was near its end. Our cable-TV committee consisted of one person. What were we to do?

#### What we did

Going up against Comcast was like David going up against Goliath. Many communities like ours were getting ripped off by the cable-TV companies, paying increasingly exorbitant prices. When appointed chair of the Cable-TV Committee for the Village, I assembled a team to try to solve the problem. We interviewed several companies that specialize in striking the best deal for folks like us with cable-TV companies. We finally selected one, Converged Systems, Inc. (CSI), to go to bat for us. Happily, their fee was a percentage of how much they could save us, not an additional expense.

#### What CSI did for us

*The goal of CSI was simple:* to obtain the best mix of service, cost, and signing bonus for us. Because Century Village is so large, we had more leverage than did smaller communities in negotiating a favorable contract. CSI helped us boil down the choices to four cable-TV companies, with Comcast being one of them. Comcast became well aware that we were doing some intelligent shopping, and if they were to hold onto us, they would have to considerably sweeten the pot. After extensive analysis and many meetings with CSI, the Cable Committee, the Officers Committee, the Executive Board, and finally the Delegate Assembly, agreed to accept a brand new Comcast offer.

## What we gained and what we lost

As you know, we **gained** the digital starter tier. We **also gained** the vast number of channels you get by pushing

the On Demand button on your remote — many movies (some pay-for, but many free); TV reruns; and a number of music channels. This applied to one TV in your apartment, whichever one you chose. The agreement was for Comcast to come by later and, for no extra charge, add two special boxes to provide us with channels 2-99 to two other TVs in your apartment. We lost our remaining two HBO channels, which many people enjoyed, but which often ran the same movie over and over again, and which we were in danger of losing anyway by Comcast's pulling them, just as they had done with our third HBO channel.

## The biggest signing bonus our attorney had ever seen

The bonus we got by signing with Comcast was the biggest that our attorney, who is an expert in cable contract law, had ever seen. It was so large — in excess of two mil**lion dollars** — that Comcast insisted we sign a confidentiality agreement to not publicly divulge the exact amount. In addition, the percentage fee we paid for CSI's services was 15%, believed to be the lowest rate of compensation ever paid by a bulk customer to this company.

### What has the money been used for?

The bonus money was used, of course, to pay this 15% and to pay our attorney. This left us so much that the UCO administration decided to take a big chunk of it to completely pay off the remaining mortgage on the new UCO building. Remember this, please, those of you who have been critical! It was then prudently decided to invest 35% of the money in CDs in case the Village had to pay taxes on the signing bonus, since this was an unknown. Every remaining penny has been returned to our unit owners to reduce the monthly cable fee for the first year of the contract. Our \$22.95-per-month bulk rate per condo unit for Basic Cable, Expanded Basic, Digital Starter tier, and 48 music channels goes for \$56.00 per month across the street from

#### Is SB 780 Unconstitutional? By Shirley Olivera

Whether or not this bill is passed in its original form or modified is neither here nor there for the present and immediate future.

There are remedies that the Associations can institute now to avoid problems later, such as:

- Accept only fully invested buyers, no mortgages.
- Increase reserves by assessing new owners a one-time Abandonment/Foreclosure fee.
- Increase annual common charges to cover a percentage of each unit's cost to carry for six months in the event of abandonment/foreclosure.

Or to state it plainly: There is no free lunch or free ride. Home ownership entails personal responsibilities and costs. Any costs assumed by a lender will eventually be passed on to all borrowers whether or not the property is repossessed in a foreclosure, tax sale, or abandonment.

The problem with condominium and other homeowner common charges is that they are shared and obligatory. The assumption is that all owners will pay their share until they dispose of the property. (See Florida's Boom & Bust economy below.)

Lenders will fight this bill because historically lenders have not been responsible for homeowner insurance, real estate taxes, repairs and maintenance. A mortgage agreement usually requires a real estate tax and/or insurance escrow reserve. Private mortgage insurance is also required if the buyer's deposit is less than 20%. These obligations protect the lender from loss in case the borrower defaults. The lender has no control over what borrowers do with their property with respect to repairs and upkeep.

If lenders use bailout funds (taxpayer funds) to bail out suffering homeowner associations, then it will be taxpayers picking up the bills. Why should taxpayers subsidize retirement and vacation communities such as Century Village with amenities that they don't themselves possess? Robbing poor Peter to pay rich Paul? I don't think it will fly in North Dakota. These funds should come out of lenders' profits, if any.

It has always puzzled me why Century Village residents are convinced that they must live as cheaply as posInsurance Dan Gladstone



A few words on the First Priority Restoration (FP) situation and why it all started. On January 1, 2009, a new company acquired Philadelphia Insurance Company that covers our water damages. The new company, that was not aware of the way our Village was run, issued an insurance policy that covered the whole Century Village with \$15,000 only for mold. In other words, there was no coverage at all.

Although the mistake was noticed by the adjusters in February 2009 and me in March, when I received the policies, the Village had to take care of the mounting damages. No adjuster would issue a report without actually seeing a written coverage by the insurance company. **Thus, no money was coming in.** 

I met FP for the first time in April 2009 during their presentation at the maintenance committee and after 3 association presidents from the audience praised their work & services. They agreed to start immediately the emergency works in the Village on my verbal promise only that the mistake by the insurance company was recognized and that it would be corrected. In other words, they were willing to work with no money in sight.

Learning from the three hurricanes that we experienced when associations had roofs blown away with no tarps or shingles available for weeks, I was looking for a company that would be ready to supply it on a moments notice. FP did. They have a warehouse ready for us next door on Vista Parkway West of us. They were also ready to supply radio communications in case of a power failure.

It took another three months until the written endorsement (Philadelphia PHPK359306) reached me on June 18, 2009. By this time FP was owed hundreds of thousands of dollars. Please note that I was not aware of how many damages were to come in the future and for me each claim was the last one.

With no money from the insurance company in sight,

I was physically involved in each claim so that all parties would be aware of the delicate situation. Furthermore, I have been always personally involved in each and every claim because I had to be sure that the insurance coverage would be there and that the insurance adjuster would not have a chance to deny the claim. In 30% of the cases, I saved the day. Claims that insurance adjusters could have been diverted to denial were ready for inspection on the positive side.

Another interesting point! In a claim situation, an association could pick one of two options. a) do the repairs on your own i.e. get bids, b) pay contractors the down payments yourself c) present the "proof of loss" to the insurance company and wait for the check. Or choose the other option, which was, to be responsible only for the deductible. That's it on your part.

FP would have to adhere to the dollar amount agreement among the three adjusters i.e. the association insurance company adjuster, the unit owner adjuster and the public adjuster that would look after the interest of the associations & the unit owners. This system took all the burden of out of pocket monies from the associations/unit owners.

The system was so successful that some opposition (in my mind politically motivated) started to protect the mighty insurance companies and complain about the large amount of money that was coming to our residents and associations. More so when the checks began to arrive, some decided to hold it although according to the agreements they were not involved in any money situation. These checks were the first of 2 or 3 to come so there was no reason to hold it until the work was done. The insured claimed that they did not want to "pay in advance" for works not finished. 1st Priority was not going anywhere because other money was owed to them. To remind you all, they were not supposed to be involved in



#### Safety George Franklin



This month, the safety subject is **golf carts**.

As we know, there are quite a few residents who own and use "Golf Carts" in the Village. In addition to residents, the majority of management companies also operate these vehicles.

I have had many questions and some complaints about the use of these vehicles in the Village. I will attempt to answer these concerns. Florida State Traffic Statute #316.2125 states that operation of a golf cart in a retirement community is permissible providing (refer to section 316.212.4) that they are operated only during the hours between sunrise and sunset unless the responsible government entity has determined that a golf cart may be operated during the hours between **sunset** and sunrise and the golf cart is equipped with head lights, brake lights, turn signals and a windshield.

Now, this is very simple to understand. If your golf cart is **not** equipped as stated, you may not operate it after sunset. 316.212.5 states: "A golf cart **must** be equipped with efficient brakes, reliable steering apparatus, safe tires, a rear view mirror, and red reflectorized warning devices in both the front and rear." Part (6) states that a golf cart may **not** be operated on a public street by persons under the age of 14 years old. Those of you with grandchildren under 14 years old, please be careful if you allow them to operate

Golf carts are considered "low speed" vehicles and may only be operated on a street with a speed limit of 35 miles per hour or less. This means that the golf carts may be operated on Century Village streets

as the maximum speed limit in the village is 25 miles per hour. Some of you take your golf carts outside the Village and onto Okeechobee Blvd. I have seen this personally. Please be aware that if you are caught, you may face a non criminal traffic infraction as a moving violation or a non moving violation, depending on the subsections charged under. In addition, if you are involved in an accident, there can be serious repercussions in the form of lawsuits for property damage and or injuries.

Another problem we have been faced with is the operation of these carts on the grass areas and pedestrian walkways. After reading the above, I would think that unless a management company is actually using the golf cart to maintain a property, such as in spraying from the cart or transferring parts of some nature to a location on property, to please use the street. I have observed what I would feel to be unsafe operation of some of these carts.

Don't forget: Just because these are small unlicensed vehicles, you do not have the right to use them in a careless manner.

These carts can cause serious injury and property damage if not used properly. Last, I would strongly suggest that you check with your insurance company and agent to be sure you have insurance coverage on your cart. There is nothing that I could find that states insurance is required. However, it would be **very** advisable to have some sort of coverage on your cart in case of accident or injury.

I hope I have helped those of you who have expressed concern and asked questions regarding these golf carts. Again, please drive safely! □

#### Recap of the Golf **Course Presentation on February 4, 2010**

The owners of the golf course gave their presentation showing an artist's rendition of the plans for a housing development they are proposing for that property. This was **not** an actual site plan drawn to scale. This was only a concept of what they would like us to see and believe. Much of the information given by them cannot be relied upon to be what would actually be built if it ever came to be.

The Pro-Active Committee gave a presentation outlining why we are opposed to any housing development on that property. The Plat 14 of the property which includes the three Southampton buildings was shown as well as the statement outlining the Perpetuity clause which states the property must always remain a golf course. A recent letter from our Attorney also emphasized that the current owners must adhere to this agreement.

A question and answer period followed the presentations and gave the owners of the golf course a good indication of how significant the numbers of residents are that oppose any housing development on the property.

We of the Pro-Active Committee are vehemently opposed to any housing development there and will continue with our pledge to do the utmost of our abilities to prevent any building on that land other than a golf course.

I hope the residents that are in agreement with our pledge will assist us in this campaign to defeat any developer with plans for the property other than a golf course.

So, stay tuned folks, there is more work to be done on this.

#### Lies, Lies and **More Lies**

A recent letter to the editor stated that because of our 10 year cable contract instigated by the cable gurus of UCO our rates went down by \$5.00 per apartment per month. This people, is not true. The cost went down because the doorway fee was applied to the cost of the residents' yearly budget; a one time, one year reduction only.

The cable contract was signed more than one year before our last contract expired, and because of this, we are paying \$349,660 more for this one year only. Yes, we did receive a doorway fee for signing this contract but we are only gaining .32¢ per unit for one year. Let's run thru the numbers. The doorway fee, which I am not allowed to print, but is in the November issue of the UCO Reporter minus \$349,660 additional cable fees for one year, minus \$215,000 paid to the negotiator minus \$15,000 paid to the attorney minus approximately \$700,000 in taxes we will pay minus \$471,240 for two HBO lost channels is a grand total of \$249.10 to the residents which comes out to .31¢ per unit. This is what you got. Next year without all these numbers factored into the budget, you can expect to pay \$11.00 or more per unit when you factor in the higher cable rate.

Yes, you did receive On Demand. Was it worth it?

from UCO's attorney, the amendment which requires that 'officers cannot be a Delegate'has been mandated by new law and should be passed. This amendment permits a seated Delegate to participate in the election of officers, although if a Delegate is elected or appointed to an officer's position, he must immediately resign from the Delegate Assembly.

Section B also required rewording so that an office created by the Delegate Assembly is not confused with an officer's position.

Section C makes the required changes from "office" to "officer.

AMENDMENT #1

#### ARTICLE VI OFFICERS

A. The officers of UCO shall be a President, four (4) Vice Presidents, a Treasurer, a Corresponding Secretary, and a Recording Secretary, and the President Emeritus. .... In addition, there shall be the office of President Emeritus. Such office The position of President Emeritus shall be held without election by each retiring President during the first term of his immediate successor. The President Emeritus shall perform such duties as may be requested by the current President, with the approval of the Executive Board. He shall be ex officio, a member of all committees except the Election Committee and the Ombudsman Commit-

A Delegate may not serve in the Delegate Assembly and as an officer at the same time. Upon becoming an officer, a sitting Delegate must immediately resign from the Delegate Assembly. B. The Delegate Assembly may create additional offices below the rank of Vice President, and may specify the duties of each such office and the requirements of election or appointment thereto; and may alter or dissolve such offices. Persons elected to any occupying such offices shall not, by virtue of their office, be members of the Executive Board, nor shall they be considered officers of UCO.

C. Any vacancy of an elected or appointed officer occurring before the expiration of a term, shall be filled by the affirmative vote of the majority of the remaining Officers' Committee Members. The filling of any vacancy in office of an officer must be approved at the next meeting of the Delegate Assembly at which a quorum is present. In the event that the remaining officers fail to agree on an appointment, or, the Delegate Assembly fails to approve the appointment, a special election by the Delegate Assembly shall be held to fill the vacancy. Such officer shall serve for the unexpired term of the seat being filled.

## ARTICLE VII DUTIES AND RESPONSI-

. . . .

F. PRESIDENT EMERITUS

**BILITIES OF OFFICERS** 

The President Emeritus shall perform such duties as may be requested by the current President. with the approval of the Executive Board. He shall be ex officio, a member of all committees except the Election Committee and the Ombudsman Committee.

\*\*\*\*\*\*

This amendment accommodates the previous change to the Bylaws establishing staggered two-year terms for Executive Board Members, and thereafter, for the election of 10 members on an annual

basis. It strikes out the soon to be obsolete language which refers to a tie vote for the 20<sup>th</sup> elected member.

AMENDMENT #2

ARTICLE VIII
COMMITTEES
E. ELECTION
COMMITTEE

....

6. In the event of a tie vote for an officer's position of UCO, the President shall call for a special election by the Delegates within five (5) working days for the candidates who received the tie vote. Should there be a tie vote for the 20<sup>th</sup> member of two or more candidates for the same seat on the Executive Board, it is up to the President to call for a runoff election as above, or name both all such candidates to the Board. If the latter option is exercised and both all such candidates are named to the Board, each candidate will be considered to have been elected by the Delegate Assembly and the number required for a quorum adjusted accordingly.

\*\*\*\*\*\*

The new law mandates that the section heading "RE-MOVAL FROM OFFICE" be changed to "REMOVAL OF OFFICERS". The removal of Officers will no longer be subject to the nearly impossible vote which was previously required. The vote to remove "directors" as per statute was 175 votes (a majority of the total number of directors) and was also required in our Bylaws. We can now employ the section of statute which refers to the "Removal of Officers", and not, the "Removal of Directors". The election of officers who basically could not have been effectively removed for any reason due to the enormous size of our Board of Directors and the extraordinary

vote requirement, has long been a great limitation in our Bylaws and yet was required by Statute. This new law which requires that our Bylaws make it crystal clear that: 1) Delegates are members of the Board of Directors (this has been previously adopted), and 2) officers are NOT directors, permits officers to be removed with a much more obtainable vote. It has been proposed that the same vote requirement to amend the UCO Bylaws (2/3 of the Delegates present) should now become the vote requirement for removal of officers. Executive Board members are not considered officers (see "F" below) and therefore, no provision will presently exist for their removal.

**AMENDMENT #3** 

## ARTICLE XI MISCELLANEOUS PROVISIONS

REMOVAL

OFFICERS FROM OFFICE
— Any officer or Executive
Board Member may be removed from office, for reason, based on submission to the President of written and signed charges, and after inquiry into the charges by the following procedure: ....

Notwithstanding any recommendation from the Executive Board the Board of Inquiry, the affirmative vote of twothirds (2/3) a majority of the entire Delegates Membership (175 votes) present at a duly called meeting of the Delegate Assembly, provided a quorum is present, is required to effect the removal of an officer. or Executive Board Member. If removal is effected at a meeting, any vacancies created thereby shall be filled in the manner provided in these Bylaws for the filling of vacancies of officers. by the members at the same meeting. F. In all articles of these Bylaws, the terms "Office" and "officers" shall not apply to members of the Executive Board

\*\*\*\*\*\*

The assignment of duties and responsibilities to the Vice Presidents (Paragraph B) and the mission and term of service of committees (Paragraph A) should be determined by the President without the required approval by the Executive Board. The Executive Board meets on a monthly basis; decisions by the President are made on a daily basis. A similar approval requirement regarding the assignment of duties to the President Emeritus by the President has similarly been deleted in new Paragraph F (Amendment #1).

AMENDMENT #4

# ARTICLE VII DUTIES AND RESPONSIBILITIES OF OFFICERS B. VICE PRESIDENTS —

The Vice Presidents shall have such powers and shall perform such duties as may be recommended by the President, and approved by the Executive Board including from time to time the designation of one of them to have all the powers and perform all the duties of the President during his absence.

# ARTICLE VIII COMMITTEES A. APPOINTIVE COMMITTEES

1. The President shall appoint such standing committees and chairmen thereof as he may deem necessary or advisable. Any unit owner in Century Village who is a member of UCO may be selected to serve as a member of any committee. The mission and term of service of any committee shall be established by the Executive Board. ...

Sometimes I think I'm just writing the SOS!!

Perhaps it is because I keep hearing the same questions and/ or comments from the other side of the desk. Same old stuff!

The past weeks have brought a continuing discussion that usually starts with the Association representative saying that "we are having a problem with people not paying their monthly assessments." And it is not uncommon for an Association to have several units that are behind in their payments. They are asked what steps they have taken to solve the situation and the answer usually is that these folks are not in residence and cannot be reached.

Two questions follow quickly. Do you have an Attorney on a retainer and do you have a bad debts line in your 2010 budget. The answers usually are "No" and "What do you mean?"

If you are in a 24 unit building and four unit owners are not paying, how do you expect to pay the November and December payments? In theory, with the exception of payments to the reserve funds, the budget is divided into twelve months and each month needs to be collected on time in order to pay that month's bills. In this case, twenty unit owners

must pay for all twenty-four and the bad debts line must reflect that amount or once again the funds will not be available to pay for the services.

If you have questions please come into the office and let's talk about it.

I have been informed that we have a new pet situation in the Village. This "pet" is rumored to come out of hiding at night and bite persons while sleeping. They are rumored to be sometimes difficult to find and can be difficult to eliminate. These creatures are bed bugs!! If you are being bitten at night or know of a unit that might have this problem in your Association — call an exterminating company for an evaluation.

I'd be remiss not to mention that the election is very close. Please listen to the candidates closely, separate facts from fiction, evaluate promises made, discuss this with your Association's Delegate and indicate to this person who you believe is the better candidate. If you wish to know my choices, just ask me. I do not feel that this column should be used for endorsements.

I hope you are having a great season and enjoying all the activities that are offered here in the Village and throughout the area. □

Many months were spent in our effort to settle our financial differences with WPRF after all the rebuilding was completed. The final settlement arrived through mediation was 3.2 million dollars. Under the chairmanship of Ted Silverman, an annual birthday party was instituted for those of our residents who reached the age of 100 and over.

The number of health fairs were increased to twice a year with the cooperation of the Century Medical Care Center and Comprehensive Home Health Care. We have also encouraged medical professionals to give lectures in the clubhouse on their specialty.

Hopefully, many of you have observed that the restoration of the shoreline has begun, under the supervision of Sal Bummolo.

Many contracts were negotiated and signed during our administration. Among them was the Security contract with Weiser, the bus contract with Community Transit and of course, the one with Comcast, among others. The much anticipated recycled water became a reality, and our lakes will now remain full.

With the rebuilding of our UCO office building we have made our Notary services available to all our residents and not just for UCO business. Because we are now able to install transponders in the back of our building, we were also able to increase the frequency of the installations to once a week. There were some additions and changes to our UCO staff. We hired an assistant to our Community Association Manager as well as a full charge bookkeeper, both new positions. Our new CAM (Rodger Carver) replaced Pat Blunck, who returned to his first love, teaching. His assistant (Clay Wynn) was just recently joined by our bookkeeper, Marilyn Lanflisi. All three are most pleasant and fit right into our village as though they have been here for ages.

The UCO Reporter is now printed in two colors, giving it a new and fresh look. As you can see from these highlights, it has been a busy and productive four years, for which I am justifiably proud. I wish my successor all the best as he takes on the reins of leadership for the next two years.  $\Box$ 

#### Maintenance Jerry Karpf



Before I start my article, I must state our policy with regard to manufacturers and anyone who lectures at any maintenance meeting:

UCO and the maintenance committee do not endorse or approve of any manufacturers, product, or contractor. All opinions of any lecturer are strictly their own and not those of UCO. This article cannot be used in any legal matter.

The January 12 lecture on Basic Finances and Reserves of Condominiums was a great success. We had about 100 people attending; the same for the lecture give on February 4 on the Responsibilities and Duties of Board members to the Association. Bill Raphan, the Ombudsman for the Department of condominiums, Land Sales, and Mobile Homes for the State of Florida gave the lecture.

Those who wish to start the installation of water valves should contact me as soon as possible, because there is a six to eight week waiting list at present. We'll try to get some additional plumbers on board so we can speed up the installation of the cutoff valves, and we'll keep everyone advised.

There are additional steps that could be taken to help prevent some water damage: (a) Get a hot water tank *alarm* which will give you notice of any water leak of your hot water tank. This item has proven to be successful in preventing major damage time and time again and can be purchased at Lowe's, or Harbor Tool in Lake Worth. (b) Have the old ball cock device, which have proven their worth to the is in the tank of your toilet, checked, and have it replaced

with a modern plastic system which should last longer than the old system.

Dan Gladstone, the Insurance Committee Chair, let everyone know why the insurance rates were increased. Part was due to the State to replenish the State insurance fund, and the other part was due to the vast amount of water damage that was sustained by unit owners here in Century Village. The total insurance increase for 2010 came to about fourteen percent. The deductible per water damage is still \$5,000. Dan also reminded everyone that if they need proof of insurance, they should contact him. He then answered all questions related to insurance.

My turn — I brought everyone up to date of the possible changes that the Florida legislature is trying to pass this year. One that is being proposed is that buildings seventy feet high would have to be retrofitted with a sprinkler system, and would have until 2025 to complete the project. If this passes and the Governor signs it, all of our four story buildings will be off the hook. Next law is that any owner in arrears on assessments or maintenance for 90 days may not run or serve on the Board of Directors. Next allows for a couple to serve on the Board together only if they own two or more units in the same association.

We will soon be having the UCO election, and it is of the utmost importance that you vote for the people who Village with actions and not words: you decide. □

#### **Problems and answers**

As with any big business deal, there have been some problems and bugs to be ironed out. Cost is not one of them, however. The UCO administration and the Cable Committee are unjustly criticized by those who complain about cost. Not only were our cable rates stable during the first half of 2009, saving associations money, but every condo owner has on average saved about \$5.00 per month in 2010. True, our cable rates will climb during the following years, but that would have been the case no matter what cable company we contracted with. Furthermore, without the contractual cap of 5% increase per year, we would be hit with the outrageous increases seen off-campus of up to 15%.

Some of our senior citizens have found the new remote difficult to figure out. I am not too surprised. New gadgets often present a problem to us older folk. Ours is not a different kind of remote, but the same one used by Comcast throughout the country. How can we help? The Cable Committee will conduct training sessions for those with lingering problems. In addition, we will launch "flying squads" of technically proficient volunteers to train and assist those, in their homes, who are housebound or handicapped; or those who just have problems with the box and remote control. I would also urge you to help one another, as many of you have already done.

Comcast has delayed on installing the second and third special cable boxes, and they have now made themselves difficult to reach by phone. Fortunately, I have developed a good working relationship with their technical people, and am able to obtain help. I receive calls every day on cable issues, and encourage any unit owner experiencing problems to call me at 683-9189, extension 106, during UCO business hours.

Television is an important service to most of us in the Village. Yes, we have taken a bruise or two, but I believe the Village has emerged a clear winner in our David-versus-Goliath battle with Comcast. All of us can be thankful for the work put in and decisions made by the Cable Committee and the UCO administration.  $\square$

Continued from Page 3 sible with respect to housing, whether principal or vacation residence. Our buildings are aging and fast becoming obsolete. They require more repairs and more maintenance to meet Code, while the cost of living keeps rising. Potential buyers who cannot comfortably assume homeowner responsibilities and costs should be discouraged.

To summarize: Century Village provides exceptional services and amenities at a very reasonable cost that many, if not most, Americans do not enjoy. The older our housing stock gets, the more it will cost to maintain it. This is the reality. **Sources of interest:**

I also had a written commitment from 1<sup>st</sup> Priority that under any circumstances **there** would be no out-of-pocket money for the association or the unit owners. The fee of the public adjuster would come from the extra insurance proceed that he would receive.

Naturally, most of the associations chose option B. Why do you want to be bothered with bids, liquidity of money etc. This was a huge success. Associations and unit owners were receiving insurance monies beyond their dreams.

UCO condition was that all jobs would be done "by the book" i.e. with County permits and inspections accordingly. No job will start without it. Apparently during the last forty years numerous jobs were done by handymen and such without proper licensing or permits which created an enormous amount of code violations.

All this was good until the election period arrived. Jealousy and envy entered the picture. I was blamed in public for thinking of myself as the "Savior of Century Village" and so forth. When my friends warned me that my rivals were waiting for me to fall I answered them that the **Insurance Committee** had passed a resolution 10 years ago to help our residents in their moment of sorrow and things were working well.

These successful achievements were a daily routine until the 2010 election time appeared around the corner. Towards the end of 2009 when I announced my candidacy for president of UCO, my rivals

began "to shoot the messenger" (me). Because UCO was in the direct line of fire and in order to avoid other innocent bystanders getting hurt, I notified UCO President, towards the end of November 2009, in writing that I would stop all activities of the "helping hand" in insurance claims. That included involvements with FP, public adjusters, A-Able for mitigation reports and other fruitful help.

Although it is heartbreaking to see the residents living out of their damaged apartments for a long time, the answer lies only with "Palm Beach County, Planning, Zoning & Building Department, the Building Division." For their own reasons, the County has held Century Village permits for weeks and months until we were to abide by the Florida State codes.


The County Building department failed every apartment that they inspected. They would not give permits and allow anyone to move in and start repairs until all the previous violations were removed. This had to be done by the unit owner at his expense before anyone could start the works.

And that, my friends, is the reason why the works were held up for months.

Remember: It took twoand-a-half years to complete our Clubhouse instead of a one year schedule.

Remember: After the Hurricane destroyed the UCO Office, the construction work took only four months to complete but it took three years until we could move in! Why? Because of "County Building Department" permits.

### Stamps in the News Syd Kronish



The "Kates" dominated the entertainment headlines in the 20<sup>th</sup> century encompassing the sound, soul, and sentimentality beloved by Americans. The ladies of note are Kate Smith and Katherine Hepburn (Kate). Both will be honored on 44¢ U.S. stamps scheduled for issuance in the middle of this year.

Kathryn Elizabeth Smith was born May 1, 1907 in Washington, D.C. and from an early age, loved to sing and dance. Her first featured hit comedy was called Honeymoon Lane on Broadway in 1926. She started her radio career in 1931, was an immediate success, and broke the record for longevity at the Palace Theater in New York City. Kate made many hit records, including the White Cliffs of Dover in 1941 and I Don't Want to Walk Without You in 1942. Her theme song was When the Moon Comes Over the Mountain, whose lyrics she helped write.

Little did she realize, however, that she would make an indelible musical mark on the American scene with her rendition of *God Bless America*. It was originally written by Irving Berlin in 1938, but he thought it was not "the right time" for such a patriotic song. The right time was his film *This is the Army*, released in 1943. It was written during wartime when the country needed an uplift — and what an uplift it was.

God Bless America has been regarded as the second national anthem of the U.S. Kate predicted that the song would still be sung long after all of us are gone — and today it is surely true. It was the last song she sang in public on a bicentennial special for July 4, 1976. She died in Raleigh, NC on June 17, 1986.

Katherine Houghton Hepburn born on May 12, 1907 in Hartford, CT., and was the oldest daughter of Dr. Thomas H. Hepburn and Katherine Houghton, an advocate for women's rights. Katherine, one of this country's most enduring and fascinating screen luminaries, made more than 40 motion pictures in roles that provided hope and inspiration to a generation of women. With her freckles, mass of red hair and preference for wearing trousers, she stood out in Hollywood. In 1933, she won her first Academy Award in Little Women.

Some of her star performances included *Bringing Up Baby* with Cary Grant in 1938; *African Queen* in 1951 with Humphrey Bogart; and nine films with her friend Spencer Tracy, starting with *Woman of the Year* in 1942. The U.S. Postal Service hails Hepburn with its "Legends of Hollywood" series for 2010. She died on June 29, 2003.

Ed note: both born in May of the same year (1907); both died in the month of June, 17 years apart. □

#### The Reader's Corner **Lenore Velcoff**



By request, I read *The Lost* Symbol by Dan Brown, which is the blockbuster novel of 2009, having sold two million copies during its first week in

Once again, Robert Langdon is the hero of this story, as he was in Brown's Da Vinci Code. He is pulled into a longstanding secret that some want revealed and others want to stay hidden. The story takes us to all the must-sees of our nation's capitol: the Capitol Building, the Washington Monument, and the Smithsonian, as well as lesser landmarks such as the National Cathedral and the Washington, D.C. 's Masonic Temple, a very interesting piece of architecture.

This book follows the familiar Brown formula: a conspiracy, a threat to the world as we know it, and a relentless villain. All the usual Brown suspects are here — the independent woman, the ambivalent Langdon, the tattooed freak and the curmudgeon with a secret. It relies heavily on tricks and code-breaking. The central theme revolves around Freemasons, symbols, pictographs, icons and Washington, D.C.

Brown has written this entire novel based on the meanings behind biblical texts and some secrets of Christianity. Some believe he wrote this book as compensation to all the Christians he offended with the Da Vinci Code. The mystery itself was confusing. Something about Noetics, CIA involvement, a single "lost" word and lots of philosophical prattle. The author pauses in the middle of a hair-raising situation to expound on some esoteric topic. Once you discover what the Lost Symbol

is, what the Masons have gone to great effort and expense for 100+ years to hide and protect, you say, "that's it?"

I was greatly disappointed by this book as it felt cold and stiff and read like a textbook instead of a novel. While this book may be for some (many), it was not for me.  $\square$

in 2009, even though it may have to be all or partly done by hand.



I reversed many insurance claim denials to the Associations into full payments. It was hard, it was nerve racking, but I was successful because I care.

When Wellington Federal was disconnected from our village and had to pay extra \$850,000 in insurance premiums, it was I who reached all the way to Tallahassee and reversed the decree. The \$850,000 was returned to the residents of Wellington, because I care.

I introduced Mitigation Reports to our village and the result was \$2,500,000 cheaper premiums on our property policies for the Associations. I also introduced Mitigation Reports to the Unit Owners and the results were up to 70% cheaper policies, because I care.

When no one believed that it was possible, I managed to get \$168,000 more for the UCO office relating to the hurricane claim under the code insurance provision, because I care.

My biggest achievement has been helping the private rsidents, hundreds of them, in their private struggle against rejections of insurance claims that can ruin their life. I have been successful in seeing to it that everyone got full payment. Why? Because I love and care for my neighbors and our residents!

I want to be UCO's president because UCO has come a long, long way in making many things happen for you, but still has a way to go to make everyone understand and appreciate what their ultimate goals are. I believe that I can lead down that road.

I have always been here for you, and I will continue to be.

After the terrorist attack on September 11<sup>th</sup>, I was recalled to set up entirely new protocols to find the perpetrators and launch new capabilities to prevent additional attacks. I know how to do research and analysis, ferret out facts, and get to the bottom of things when faced with a question, I do not guess; I get the accurate answer. I also know how to delegate. I have been a vice president of UCO now for the past year, in that short time, I have created the kernel of an Information Technology department to maintain the UCO Computers and the network that controls the gate security system and the UCO telephone network. I have been the president of my association for five years, and I serve on a number of UCO committees; such as Advisory, Cable, Security, Operations, Insurance, and Finance. When complex questions need to be researched, which require correct answers; I do that research for UCO.

What are my main concerns? It troubles me that our people go into UCO and are sometimes treated rudely. It troubles me also that UCO personnel too often give out misleading or just plain wrong information. It troubles me that some of our operations are so cumbersome and time-consuming. With the cooperation of the officers and the Delegate Assembly, I will change this. Clearly the goal is to place more professional and highly experienced personnel as part of the UCO staff. Prime candidate departments for personnel upgrades would be Finance, Investigations, and Information Technology and Communications. I am dedicated to total transparency in UCO Operations no secret gatherings and decision

making in the dark; My UCO Administration will say "YES" at every possible opportunity. It is my unalterable task to stop UCO interference in Association affairs.

What operations would I change? Two are most urgent. We need to simplify the procedure for getting transponders. We need to install transponders "on demand," no more nonsense of making appointments weeks in advance; if you come in for a transponder, you will get it then, not later; no more keeping people waiting inordinate lengths of time. We also need to make the procedure for getting prospective owners and renters investigated and approved a smoother and faster process. A professional needs to be brought in to assist with our investigative procedures so we do a much better job of it and avoid legal pitfalls.

Century Village is a medium-size town. With 14,000 in-season residents and a multi-million dollar budget, it is essential we do things right. UCO is a servant to the 309 Village associations, not boss. It needs to be a thoroughly honest servant and a competent servant, but also a servant that knows its bounds. Well-meaning people need to take care to not "play attorney."

Insurance is an association's biggest single expense. The cost of insurance far exceeds what is paid to our management companies. We need something more than a "one trick pony," as persuasive and able as he or she may be, controlling our overall insurance operation. We need the entire Committee to understand it thoroughly, be able to explain the details of it to others, and be able to act as a check on one another. Too much is at stake to not have this. UCO needs to adhere to the strict contractual requirement of the Bi-lateral Agreement-that is, to simply negotiate the policies. UCO's name should not be anywhere on an association's insurance policies. UCO should not be involved in any way with arranging for repairs or remediation contractors. The individual associations should file their claims, find and select their own contractors, and call in a public adjuster if needed. The associations must deal directly with our Insurance Agent or Insurance Company, as required. We must learn the names and telephone numbers of our agents working in the Plastridge Agency, or perhaps in another agency that might be more attuned to our needs in CV. Finally, in accordance with Florida Statute FS-718, each association must have a copy of each of their insurance policies as a part of the association records — not merely the declarations pages, but rather, the entire set of policies. These should be obtained, not from UCO, but directly from the insurance agent(s) involved or the insurance companies — in the same way you get your automobile or homeowner's policy. No association should have to come to UCO to get its association policies. That some associations have done this and then been stalled and put off is intolerable.

Blowing the whistle. On our Century Village Website (http://century-village-wpb.blogspot.com/) that some of you read, I and others have blown the whistle on numerous occasions about questionable and improper Village goings-on. *As president, I'll be in a much better position to protect your interests.* Your Constitutional rights of free speech must be upheld without censorship. As your UCO president, I will serve you faithfully and well — just as I served my country when I worked for the U.S. government for over 30 years, and in the United States Army for three years.





Sins of the Mother by Israel Horovitz

Israel Horovitz' record as a playwright is truly remarkable. He's written over 70 plays, many still performed. His works have been translated into 30 languages. Of all American playwrights, he's the one most produced in France. His play *Line* continues to run off-Broadway, where it opened 37 years ago, making it New York's longest running show. To top it off, he turned 70 last year. By way of celebration, he's being honored with something called 70/70 Horovitz Project, with all of his plays being performed in American theaters across the country.

At Florida Stage in Manalapan, you can see one of his newer works, Sins of the Mother, through March 7. Act One is set in a "Stevedores' union room, fish-processing plant, Gloucester, Massachusetts." Three Vietnam War veterans greet a young newcomer, who once lived in town but later moved away. It develops that one of the vets loved his mother, who ultimately died from a drug overdose. Act Two is set in the "living room, Bobby Maloney's house, Gloucester, Massachusetts." There is also an Epilogue.

Act One was originally written as a one-act play attempting to tell some of the troubles befalling returning Vietnam War veterans, including the fact jobs are scarce and drugs are prevalent. Much serious talk unfolds about relationships, and there are


references to the world of the unemployed. The end is startling; melodramatic. Mr. Horovitz, apparently upon the advice of professional colleagues, decided to add a second act.

Act Two has three of the four characters we saw before plus the brother of one of the older men. But this act is different. No longer a drama, the play has turned into a black comedy. The plot makes sense, for it flows logically from what transpired earlier, yet the mood change is jarring, at times even weird. At one point, the stranger compares Oprah to Jesus Christ. The comparison is intended to be humorous, but I don't believe for an instant that any of Act One's characters would know what he's talking about. This "brother" is not a soul they can relate to. Still, there are serious topics: parental abuse of children; the return of jobs.

Mr. Horovitz directed his own play, so I have to say the results are definitive. The cast is very good: Gordon McConnell, Francisco Solorzano, Brian Claudio Smith and David Nail clearly understand what is wanted, and they deliver.

Taken as a whole, I rather liked the play, despite the fact I found it at times to be confusing. Still do. I actually preferred Act Two and its upside-down Epilogue to the largely predictable if more defining Act One. See for yourself, and decide. 
